Dear Interested and Affected Party

Please find herewith the link to the electronic documents for the Kingsburgh X9 Basic Assessment Report for your perusal.

There was a delay between our first communication and the production of the Draft Report, as the developer has significantly reduced the numbers of dwellings proposed, and therefore the plans had to be revised and the information in the Basic Assessment amended.

The reduction in numbers of units proposed reduces many of the potential impacts identified in the initial consultation (traffic etc).

The comment period was planned for the 27 March to the 30 April, however, as a result of the lockdown due to Covid-19, it has not been possible to place a report in the library or send hard copies to the various Government Departments who require them. This will be undertaken once lockdown is over, and an additional 30 days will be added to the comment period.

However, I recognise that some people who have access to the Internet may appreciate the extra time to peruse the report during lockdown, so it was decided (with the approval of EDTEA – the Competent Authority) to send out the report electronically now, and ensure that there are still an additional 30 days to comment after lockdown is over.
