Project Background: Metamorphosis Environmental Consultants has been appointed by Klipplaats Family Trust to undertake an Environmental Authorisation process for the proposed Wembezi Commercial Development on Portion 51 (of 7) of the Farm Klipplaats Drift No 1009, uThukela District Municipality.

Project description

Phase 1 of the development will involve the development of shops, a taxi rank, offices and a service station (storing 69 000 m3 of fuel) covering an area of about 7 ha. Phase 2 of the development will involve the creation of eighteen (18) plots to be zoned for light industry, each approximately 0.5 ha (approximately 10 ha in total).
