Isicelo: i- Metamorphosis Environmental Consultants iqashwe yi- Klipplaats Family Trust ukuba iphathe isicelo sezemvelo mayelana nokuhlongozwa kwentuthuko yezentengiso ezoba ku Portion 51 (ka 7) owefamu i- Klipplaats Drift Namba 1009, ngaphansi kwamasipala u-Thukela.

Umsebenzi ohlongozwayo: Isigaba sokuqala salentuthuko sizofaka ukwakhiwa kwegaraji elizogcina uphethiloli nodizili okunomthamo ka 69 000 m³, indawo ezothathwa ilesisigaba sokuqala ihlawumbiselwa kuma hektha ayisikhombisa (7 ha). Isigaba sesibili sizofaka ukwakhiwa kwamasayithi ayishumi nesishiyagalombili (18), azobe esetshenziselwa amabhizinisi ahlukenene. Isayithi ngayinye izoba nguhhafu we hektha (0,5 ha) usayizi . Mase ehlangene wonke lamasayithi, azokwakha amahektha alishumi (10ha).
